»»» **CONTACTING THE LEAGUE**

Please be reminded that only the listed secretary or the additional contact listed on the league admin site are permitted to contact the league. Charges will be issued to clubs that fail to comply.

»»» **SPONSORSHIP**

The league are currently actively looking for sponsors. Please contact Stewart Walker if you require more information.

»»» **REFEREE LOW MARK REPORTS**

If you feel that the referee for your fixture deserves a mark of 60 or lower, your club secretary must submit a report to Stewart within 5 days of the fixture. Failure to do so, will result in a charge as per league rules.

»»» **PHOTO ID'S**

Please be reminded that it is a mandatory requirement as per league rules that ALL teams MUST show their Photo ID sheet to the opposition before EVERY match.

Referees will not get into registration disputes and any concerns should be raised with a committee member.

These can be printed off from the FA Club Portal.

»»» **REFEREE PAYMENTS**

Please ensure referees are paid in CASH unless otherwise agreed beforehand with the referee as per league rules.

»»» **VIDEO/PHOTOGRAPHY**

Please ensure that you familiarise yourself with FA regulations in regards to video/photography on match days.

»»» **LEAGUE CUP FINALS**

Please note that the league are currently looking to confirm venue and exact dates for finals. These will likely be across the weeks of w/c 4th & 11th May. We will update once we have further information.

»»» **FIXTURE CHANGES**

All changes to fixtures must be done at least 14 days before. If within 14 days, the league, opposition & referee must agree to the change.

»»» **DEADLINES**

- Home Team to confirm match with opposition and referee - 5 days before
- Team sheets swapped between teams and referee - 15 minutes before KO
- Result of match submitted via SMS - by 6pm Sunday
- Team sheet submitted via full-time - 3 days after

Failure to meet deadlines will result in a charge as per league rules.
